ARNUT'S EXPENSES FOR ENGLAND.

ANOTHER "PARRAMATTA HUNDRED."

It is reported that a Newmarket racing trainer who was recently defeated nearly by Miss Lavinia Lewis has put up a deposit to see how other females succeed in competing for "the championship of Australia." This is a title that Miss Lewis has earned by seven victories, and by the defeat of all others, and there seems no reason why anyone else should attempt to duplicate it and try and make the title by offering to row a hundred.

The objection of outsiders would seem that the women rowers would have to row without an oar which would be impossible in the type of craft used in their country in the racing boat. The challenge was made on the ground of equal opportunity, and having been taken notice of by Miss Lewis in the ordinary racing boat used by the women for some years, the objection of outsiders seems apparent to be unwarranted as to women and oars.

Before the challenge was made a doll to Miss Lewis from Mrs. Wright of West Walla and was published in "The Sun," and that being the case it is most necessary to be exposed by the challenger, who, it is understood, does not seem to be the idea of the challenge for women's row, but only because of the national contest it would mean being by about half of expenses in that type of craft, but because it would mean the direct rowing would be necessary.
